ROLE PURPOSE:

ROLE PURPOSE:

The jobholder is responsible for leading MEAL functions across the assigned location (Magwi/Abyei)) to the MYRP programme in liaison with the MYRP MEAL Manager and under the direct supervision of the MYPR MEAL Coordinator. The function will work closely with the Education Coordinators, project teams across the location of posting.

The role directly tasked to ensure the implementation of the MEAL system's in the field location to ensure harmonised and aligned data collection and monitoring to inform decision-making, accountability, reporting and learning in a timely and strategic manner. The MEAL Officer ensures that the program undertakes routine monitoring that will inform Continuous Quality Improvement, conduct data quality assessment, develop information briefs and create platforms for regular sharing of Programme updates. The role will ensure that mechanisms for collecting, tracking and responding to feedback and complaints from Programme stakeholders implemented and are operational.

KEY AREAS OF ACCOUNTABILITY:

A: Program design.

- Assess the needs and capacities of the target communities, involve communities in problem analysis, and project design.
- Ensure a clear understanding of the project design among the project teams and facilitate implementation
 of key design approaches to the programme in liaison with the MYRP MEAL Coordinator.

B: Operationalize MEAL in the field locations.

- In close collaboration with the MYRP MEAL Coordinator, operationalize the MEAL plan including setting
 up of mechanisms to monitor and document the progress of implementation of Programme activities.
- Ensuring that MEAL planning and discussion held with project staff and stakeholders during project implementation.
- Ensure the project MEAL templates (Trackers, Quality Benchmarks, IPTTs, Accountability Trackers, Data Audit and Learning Plans) updated and the project team facilitated to undertake key MEAL initiatives.
- Results monitoring and Learning for decision making by tracking and maintaining Project Performance Tracker (IPTT) to flag/address required performance improvements on monthly basis
- Conduct and update monthly IPTT and Quality Monitoring (using quality benchmarks) and coordinate data collection in the field location.
- Act as the focal point for the field location to ensure data collection tools updated and respond to program indicators.
- Implement data quality assurance activities according to the MEAL plan (e.g. data verification and spot checks).

C: Design and Operationalize Accountability Systems.

- In collaboration with the MEAL Coordinator, facilitate accountability assessments and reviews to inform establishment of accountability systems.
- Support the project team in the development and sharing of information sharing materials/briefs, posters
 and brochures, and dissemination of Programme information materials to relevant stakeholders, partners
 and beneficiaries.
- Collect and manage complaints and feedback in close coordination with Programme team in the field office. Track timeliness of response to complaints and maintain an updated Programme complaints tracker.
- Adopt Child Safe Guarding and Safe programing into accountability mechanisms for the consortium.

D: Build culture of Learning and Knowledge Management

- Guided by the MEAL Coordinator collection of quantitative and qualitative data to inform key learning initiatives.
- Coordinate with the project team to document lessons learnt, best practices and case studies and Facilitate field based dissemination sessions with the project team.

E: Other Duties

Perform any other duties as may be assigned from time to time by line Manager.
